## **Fun Rally**

**Saturday, June 08, 2019**

**Location: Berg-Solomon Farm, 16307 Kennedy Road, Stouffville L4A 2R9 (on the east side of Kennedy Road just north of St. Johns Sideroad)**

**We have created an opportunity to participate in a one-day event setting, at the level you are comfortable to ride at, in all three phases. Mix and match at your comfort level!**

**The idea is to leave with judge's feedback to improve your skills and have fun!**

**Overnight Accommodation: If you are participating in the PPG meet the following day, you may rent a stall 10 min away at The Gait, (6296 St. John's SR, Stouffville) for \$20. You must provide your own shavings and clean up and remove all garbage! You may camp on the Berg-Solomon property.**

**Dressage – Score sheet and comments will be given to the rider.**

**Equitation Over Fences – Judges will give you feedback on your control and style over a course of jumps.**

**X-Country - Coaches will be on the X-Country course to assist you safely to the finish line. A safety vest is recommended.**

- **If you are taking a long time to negotiate an obstacle you will be asked to stand aside to let the next rider move past you.**
- **If you are un-successful at an obstacle you will be able to miss it and move on to the next, allowing you to finish the course rather than being eliminated.**
- **Riders who are unsafe will be asked to dismount and return to the trailer.**
- **CPC Safety and concussion rules do not permit a rider to remount and continue if they have fallen off.**
- **Jump Heights reflect 2019 rules, levels are approximately same as prior years**

## **Division & Classes**

### **Level 1: Walk, Trot**

**Dressage - CPC Entry Level 1 Test**

**Equitation Over Fences - walk, trot over poles & tiny X rail**

**X-Country - walk, trot over poles and tiny log course in open field (riders may be accompanied by a leader/side walker on X-country)**

### **Level 2: Walk, Trot, some canter**

**Dressage – CPC Starter Level 2 Test**

**Equitation over Fences – walk, trot, canter max height .70m**

**X- Country – max height .70m**

### **Level 3: Walk, Trot, Canter**

**Dressage – CPC Pre-Training 1 Test**

**Equitation over Fences – max height .75m**

**X- Country – max height .75m**

### **Level 4: Ride with confidence and control over all terrain at all paces**

**Dressage – Cadora First Level “C” Test**

**Equitation Over Fences – max height .9m**

**X-Country – max height .9m**

**Most jumps on the course will be below the maximum height.**
