Please review the updated COR Rally Rules 2023 posted on the 'Downloads' section of the COR site: www.canadianponyclub.org/CentralOntario/index.htm This year we will be running a division for each of the following levels:

Grasshopper – Stadium **max 25cm**, Cross Country **mandatory flags** (no jumps)

Starter – Stadium max **60cm**, Cross Country - max **60cm**

Pre-Entry – Stadium max **78cm**, Cross Country max **78cm**

Entry - Stadium max **85cm**, Cross Country max **85cm**

Pre-Training - Stadium max **90cm**, Cross Country max **90cm**

All divisions are open to anyone regardless of tested level. Horsemasters will be scored separately from youth members.

Dressage tests: Grasshopper - Canadian Pony Club Starter Test 1, Starter - Canadian Pony Club Pre-Training Test 1, Pre-Entry - Canadian Pony Club Pre-Training Test 2, Entry - EC Eventing EV85 Test 1, Pre-Training - EC Eventing EV 90 Test 1

The official course walk will take place at a time to be determined before competition starts. Details will follow (in a COR Comm or on the website).

PRIZE LIST Ribbons will be awarded to 6th place overall. Ribbons will be awarded to the top three teams for Stable Management, top Non Riding Captains, as well as to the 5 top grooms. Prizes may accompany some awards.

DEADLINES: Completed entry forms and waivers are to be received no later than Friday Aug 9th. if you want to pay the pre entry fee. Final deadline of Aug 16th. If entries are not submitted in full before Aug 16th a late fee of \$25.00 per competitor will apply.

No entries will be allowed after Wednesday, Aug 21st, 5:00 p.m.

No changes will be accepted after Friday, August 23rd.

START TIMES will be posted on the COR web site Friday, August 23rd

All forms must be signed by the appropriate people. This includes waivers for all of the participating grooms and captains.

General Rules:

- Make sure that all of the participants, including grooms, have proper footwear. No sandals or running shoes.
- Please make sure you are aware of the COR Dress Code, posted on the COR web site.
- Everyone wears their appropriate Pony Club pin with its disk at all times, except during the cross country phase where riders are not to wear the pin for safety reasons.
- Each branch **must** supply 1 Adult Supervisor (see job in COR Rally Rules, section 4.5) and **may** supply 1 adult handler for every four riders registered. Adult interference or assistance could result in elimination for the entire team. Take advantage of not being the groom for a change. This is about teamwork and leadership.
- **Each branch needs to supply a minimum of two cross-country jump judges. If you cannot make your commitment, make sure someone is there to take your place.**
- The event runs rain or shine, but in the event of a thunderstorm, it may be cancelled.
- If your horse kicks, put a red ribbon in his tail.
- Each Branch must have a non-riding captain, if you do not have a member in your branch, for this position contact the organizers, who will attempt to find one from another branch (if you have someone would like to be a non- riding captain also please let us know).
- NO DOGS ALLOWED ON PROPERTY

There is limited stabling available on-site you must get in touch with me and I will ask on your behalf.

AGREEMENT FOR RELEASE AND WAIVE- riders & grooms

Entry at the COR Rally shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider, and the horse shall be subject to the Constitution and the Rules of the Canadian Pony Club, Equine Canada, and the local rules of the Competition, and that every horse/rider is eligible as entered and that the owner and any of his/her representatives are bound by the Constitution and Rules of the Canadian Pony Club, Equine Canada and the Competition; accept as final the decision of the hearing committee/ground jury on any questions arising under said rules and agree to hold the Competition, Canadian Pony Club, Equine Canada, their officials, directors and employees harmless for any action taken.

Effective January 1, 2003, Equine Canada required that Junior competitors wear proper fitting, approved protective headgear, with the safety harness correctly secured, at all times while mounted on competition or event grounds. Approved headgear meets the ASTM (American Society for Testing materials) standards and displays the SEI (Safety Equipment Institute) seal. The British standard, BSI, is also acceptable. It is understood that if the competitor does not meet this requirement that he/she will not be allowed to compete at this rally.

I, _____ (competitor's name) do hereby certify that I, the undersigned, have read and understood the rules governing this show/competition and hereby agree to abide by them. I recognize that equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless the Canadian Pony Club, Equine Canada, the Club, host Pony Club, Staff, Organizers, Property Owners or any person acting on their behalf, shall not be held liable for any loss, damage, injury or illness including death to horses, riders, spectators or any other persons or property.

I hereby release the ORGANIZING COMMITTEE, the FACILITY- LANES END FARM, operated by Susan Lavery, its servants and agents from any liability arising out of my participation in this competition; and any liability to competitors, trainers, grooms, volunteers, spectators, animals or vehicles.

COACHES

Name: _____

The role of a coach is to assist the rider

1. In the warm-up area,
 2. In the course walk
 3. Assist rider in learning the rules of competition before competition begins.
- ◆ The presence of a coach at a Competition is to promote safety, good sportsmanship and good horse mastership in the warm-up area and the competition ring.
 - ◆ The coach is not present to give a riding lesson in the warm up area.
 - ◆ Teams/individuals may share a coach.
 - ◆ The coach's name(s) must be included on the entry form. Any substitution or addition of coach must be reported to the organizing committee prior to the start of the competition.
 - ◆ The coach must be familiar with and comply with the current CPC for Rally Rules, Central Ontario Region rally rules and should assist riders in learning these rules before the competition begins.
 - ◆ During any post round briefing the coach must not interfere with the riders care for their horse.

The duties of a coach shall be limited to the jumping phases of competitions and may include:

1. Observing, but not participation in, any pre-competitive soundness check and any daily soundness checks.
2. Accompanying competitors during course inspection or at any other subsequent times that the courses are open for walking, during which they may give advice and coach
3. Assisting competitors in the designated Exercise Area.
4. Briefly meet with the rider after the round for feedback on the round, if the rider desires. This meeting will be held in or very near by the gate to, the Exercise Area; and under no circumstances will interfere with the care of the horse. Coaches who are interfering may be asked to leave the exercise area

A coach may request an adjustment of tack from the Chief Steward.

1. If permission is granted, after the adjustment is made, the competitor must return to the Chief Steward for a safety check of the adjustment.
2. Permission for changes must be requested before the change is made.

At all times coaches must be aware of the unauthorized assistance rule. They must not enter the stable area except at authorized visiting times.

Violations of these coaching guidelines will be penalized by the chief steward/judge/ground jury.

I have read and understand the above and agree to abide by these guidelines and by the competition rules.
